# The Umeå University Multidisciplinary Research Programme on the Barents Region

# Background

The initiative to establish a cross-border collaboration project in the Euro-Arctic Barents Region was taken in April 1992 by the former Norwegian Minister of Foreign Affairs Thorvald Stoltenberg. At a meeting in Kirkenes, Norway, on the 11 January 1993, between the foreign ministers of the countries involved a declaration of co-operation was signed between the Nordic countries, Russia and the EG Commission. Through this declaration the Barents Council was established. In addition to yearly meetings at the foreign ministerial level meetings should also be arranged between the ministers of the environment, communications, culture, financial affairs and business relations under the auspices of the Barents Council. Furthermore, the importance to establish a strong regionally based collaboration was emphasized. Thus, to a great extent the collaboration is supposed to be conducted by actors on the local and regional level in initiating and coordinating roles. Special attention should, for example, be drawn to the situation of the indigenous peoples.

In the Barents co-operation declaration a broad repertoire of co-operative forms and measures are envisaged. Much of this presumes, at least in the short term, that financial resources can be mobilized in the Nordic countries or in other parts of Western Europe. The environmental problems are of a central interest, in particular civilian and military use of nuclear power as well as the deposition of nuclear waste. Scientific and technical co-operation is evidently important ingredients both in the work that has to be devoted to the solution of pollution problems, and in the work that is aiming at achieving a more efficient use of the region's natural resources.

Emphasis is also put on the development of an economic co-operation. Agreements will have to be reached about forms for trade exchange and other business relations across the Russian border. The importance of developing collaboration concerning energy conservation, restructuring of military industries and establishments for civilian use as well as achieving an increased level of efficiency and quality in agricultural production in the Russian part of the region are specifically mentioned in the agreement.

Another important area of co-operation is the improvement of transport and telecommunication facilities. The volume and timing of infrastructural investments form significant prerequisites for the manner in which contacts and collaboration will develop.

In order to foster the interest in co-operation in such a politically, economically, ethnically and linguistically diverse region great attention must be devoted to activities of a social and cultural character. This fact is also emphasized in the declaration of co-

operation. To develop the region's cultural identity and common profile towards the surrounding world is a crucial task for the regional Barents Council. A transregional identity project cannot be elaborated by actors at the national level.

# Research about the Barents Region at Umeå University

The existing situation in the Barents Region provides a strong motive to create an active and multifaceted R&D co-operation. Such a co-operation might contribute to the satisfaction of the needs of information, to finding solutions to problems, to making obstacles and opportunities for co-operation more clear and, in general, to implanting "seeds of togetherness". Furthermore, the R&D communities in the Russian parts of the region badly need to improve competence through a widening of their external relations. The degree to which the restructuring towards a sustainable resource use, a competitive market economy and an increasingly democratic political life succeeds might depend upon how well import of new knowledge and its implementation can be achieved.

During the last few years a number of research activities concerning the Barents Region have been initiated at Umeå University. This focus of interest has recently been significantly substantiated. Today, several projects are investigating a number of economic, political, and ecological aspects of the changed situation in the region. For obvious reasons this research is to a large extent conducted in collaboration with other universities and research institutions. A determined effort to establish collaboration with researchers in different parts of the Barents Region has brought Umeå University into an extensive research network devoted to the study of issues related to the development of the region.

It is natural to pay special attention to the Russian situation in order to understand the problems and opportunities that present themselves with the establishment of the Barents Region. In Russia we find many of the serious environmental problems that complicate and even threaten an intensified co-operation in the new region. At the same time here we also find the largest population concentration, unexploited natural resources and a huge constrained consumption demand, a fact that in itself represents a potential development opportunity.

To study Russian life requires good relations to Russian researchers and the establishment of such relations requires long and persistent efforts. Thus, a necessary step in the establishment of research about the Barents Region is to strengthen and widen the contacts that have already been established with Russian researchers and scientific institutions. In Umeå there are researchers with the linguistic competence that is required to achieve a fruitful collaboration with Russian researchers. As a part of the long term effort to develop contacts and strengthen the linguistic competence on the Russian side younger Russian researchers are continuously invited to spend some time on scholarships at Umeå University.

# The Barents Programme

The research about the Barents Region that is currently being conducted at Umeå University is primarily connected to the Centre for Regional Science (CERUM) and the departments of Political Science, Economics, Health and Environmental Protection and Environmental Chemistry. In order to improve the information between the departments engaged in research about the Barents Region and to improve coordination in the endeavours to find financial support for these research activities CERUM has established a special *programme committee*. People who are, in one way or another, engaged in issues relating to the Barents Region have been invited to become members of this committee. The programme committee has elected a smaller steering group which consists of the following people:

At its inaugural meeting on January 18, 1994, the programme committee decided that the activity developed by the committee should be labelled *The Barents Programme* — *The Umeå University Multidiciplinary Research Programme on the Barents Region* and that the goals of this activity should be:

- to initiate and procure the support for social scientific, natural science and humanistic research on problems related to the Barents Region,
- to work for a further development of research co-operation in the region, and
- to distribute information about on-going and planned research concerning the Barents Region.

The committee should also organize seminars and conferences on the initiative from the researchers participating in the network of the committee. In connection with these seminars and conferences everyone interested should be offered an opportunity to discuss issues related to the activity in the programme.

The programme committee should be regarded as a resource for researchers who wish to initiate studies about problems related to the Barents Region. Researchers should be able to turn to the committee to discuss their ideas, evaluate the possibilities to find financial support and to ask for contributions to cover costs that might arise in connection with, for instance, journeys in the region.
